Boarding Kennel Contract

CONTRACT BETWEEN <u>JUNE'S PET RESORT L.L.C.</u> and the Pet Owner whose signature appears below (Hereinafter Called "Owner").

Owner agrees to pay the rate for boarding in effect on the date pet arrives, <u>by check or cash only</u>. If Pet becomes ill or if the state of the animals health otherwise requires professional attention, the Kennel, in its sole discretion, may engage the services of a veterinarian or administer medicine or give other requisite attention to the animal, and the expenses thereof shall be paid by the Owner.

Owner agrees that the pet shall not leave the Kennel until Owner pays all charges to the Kennel. By signing this Contract and leaving the pet with Kennel, Owner Certifies to the accuracy of all information given about said pet on back of contract.

The owner agrees that the kennel assumes NO ownership or guardianship and there for No liability associated with animal. Kennel shall exercise reasonable care for the pet delivered by the Owner to Kennel for boarding. Agreed by Owner and Kennel that the Kennel's liability, in no event exceeds the lesser of the current chattel value of a pet of the same species or the sum of \$300.00 per animal boarded expressly agree it. The Owner further agrees to be solely responsible for all acts of behavior, if it bites another pet or people of said pet while it is in the care of the Kennel, for boarding or grooming.

Owner specifically represents that he or she is the sole owner of the pet, free and clear of all liens and encumbrances. Owner specifically represents to Kennel that the pet was not been exposed to rabies or distemper within a 30-day period prior to boarding.

The Kennel will grant a lien on the pet for all unpaid charges, resulting from boarding pet at the Kennel. The Owner hereby agrees that in the event the boarding charges are not paid when due in accordance with this contract, the Kennel may exercise its lien rights upon ten days written notice given by Kennel to Owner by certified mail, to address shown on contract. Kennel may dispose of pet for all unpaid charges, at private or public sale, in sole discretion of the Kennel, and Owner specifically waives all statutory or legal rights to the contrary. If such sale shall not secure a price adequate to pay such costs of board or other charges delinquent, plus costs of sale, then Owner shall be liable to Kennel for the difference.

This Contract contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators and personal representatives' of the Owner.

If any controversy or claim arising out of or relating to this contract, or the breach thereof, or as the result of any claim or controversy, involving the alleged negligence by any party to this contract. The claim will be settled, by arbitration in accordance with the rules of the American Arbitration Association. The judgment leading to the award, rendered by an arbitrator in Madison County Court having jurisdiction there. The arbitrator shall as part of this award, determine an award to prevailing party of the costs of such arbitration and reasonable attorney's fees of the prevailing party.
