

Boarding Kennel Contract

- **CONTRACT BETWEEN JUNE'S PET RESORT L.L.C. and the Pet Owner whose signature appears below (Hereinafter Called "Owner").**
- **Owner agrees to pay the rate for boarding in effect on the date pet arrives, by check or cash only. If Pet becomes ill or if the state of the animals health otherwise requires professional attention, the Kennel, in its sole discretion, may engage the services of a veterinarian or administer medicine or give other requisite attention to the animal, and the expenses thereof shall be paid by the Owner. Supplying medications for your pet at check-in permits all Kennel employees to administer these medications without any liability to the Kennel and its employees.**
- **Initial _____ Owner understands that certain "activities" that the pet may participate in, including but not limited to doggie daycare, boarding and/or play, involve risk to pet and possible injury illness. This includes but is not limited to:**
 - *Exposure to parasite, viruses, and other infectious diseases passed form pet to person/person to pet.**
 - *Bites, Lacerations, sprains, strains, broken bones, paralysis, orthopedic injury.**
 - * Illness including diarrhea and vomiting, fatigue, dehydration, heatstroke, death.**
- **Owner understands that pets enrolled in daycare or boarding at Junes Pet Resort where pets will freely interact and may play roughly. June's Pet Resort takes all responsible safety measures and precautions, it is understood by owner that Junes pet resort will not be liable of any injury or illness to pet while in our care.**
- **The Kennel will grant a lien on the pet for all unpaid charges, resulting from boarding pet at the Kennel. The Owner hereby agrees that in the event the boarding charges are not paid when due in accordance with this contract, the Kennel may exercise its lien rights upon ten days written notice given by Kennel to Owner by certified mail, to address shown on contract. Kennel may dispose of pet for all unpaid charges, at private or public sale, in sole discretion of the Kennel, and Owner specifically waives all statutory or legal rights to the contrary. If such sale shall not secure a price adequate to pay such costs of board or other charges delinquent, plus costs of sale, then Owner shall be liable to Kennel for the difference.**

This Contract contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators and personal representatives of the Owner.

If any controversy or claim arising out of or relating to this contract, or the breach thereof, or as the result of any claim or controversy, involving the alleged negligence by any party to this contract. The claim will be settled, by arbitration in accordance with the rules of the American Arbitration Association. The judgment leading to the award, rendered by an arbitrator in Madison County Court having jurisdiction there. The arbitrator shall as part of this award, determine an award to prevailing party of the costs of such arbitration and reasonable attorney's fees of the prevailing party.
